

NOTICE TO TAXPAYERS
HEARING ON PROPOSED LOCAL INCOME TAX
ORDINANCE # _____

Notice is hereby given to the taxpayers of Pendleton, Madison County, Indiana, that the Pendleton Town Council, will consider at a Special Meeting to be held at 100 West State Street, Pendleton, Indiana, 46064, at 6:00 p.m. on the 27th day of October, 2021, the following proposed ordinance regarding the local income tax imposed within Madison County:

“ORDINANCE MODIFYING LOCAL INCOME TAX RATES
PENDLETON, MADISON COUNTY

BE IT ORDAINED by the Town Council of Pendleton, Madison County, Indiana that a need now exists to modify the local income tax rates imposed in the following way:

Allocation Rate Category	Existing LIT Rate	Proposed LIT Rate
Certified Shares (IC 6-3.6-6)	1.00%	1.00%
Public Safety (IC 6-3.6-6)	0.25%	0.55%
Economic Development (IC 6-3.6-6)	0.00%	0.00%
Property Tax Relief Rate (IC 6-3.6-5)	0.50%	0.50%

The local income tax rates proposed above will become effective on January 1, 2022.

BE IT FURTHER ORDAINED that a public hearing was held on the proposed local income tax rate modifications on October 27, 2021. Proper notice of the public hearing was provided pursuant to IC 5-3-1.

Duly adopted and approved by the following vote of the members of the Pendleton Town Council this ___day of ____, 2021.”

After the public hearing, the Pendleton Town Council may take action on the proposed ordinance. There is no remonstrance opportunity on any action taken on the proposed ordinance. The public hearing identified above is the taxpayer’s opportunity to express concerns and ask questions on the proposed ordinance.

Written objections to the proposal that are filed with the Pendleton Town Council at or before the Hearing will be heard. The Hearing may be continued from time to time if necessary.

Due to the COVID-19 emergency, the Governor has issued Executive Orders allowing governmental agencies to conduct meetings virtually during the course of the public health emergency. Please be advised that if a virtual meeting format is allowed, this is in addition to an in-person meeting at Pendleton Town Hall.

It is the policy of the Town of Pendleton, that all public meetings and events comply with Title II of the Americans with Disabilities Act and are accessible to people with disabilities. Individuals with disabilities, as defined under the ADA, who may need auxiliary aids, services, or special modifications to participate in a public meeting or event should contact the office of Pendleton Clerk-Treasurer, as soon as possible, but no less than forty-eight (48) hours before the scheduled meeting or event.
