ORDINANCE NO: 24-07

#### ORDINANCE ABOLISHING THE TOWN MARSHAL SYSTEM AND ESTABLISHING THE PENDLETON BOARD OF METROPOLITAN POLICE COMMISSIONERS

**WHEREAS**, the Town Pendleton Police Department currently operates under a Town Marshal system, as provided in Indiana Code 36-5-7; and

**WHEREAS**, Indiana Code 36-8-9-2 authorizes the Town Council, by ordinance, to abolish the Office of Town Marshal and to establish a Board of Metropolitan Police Commissioners to govern the operation, management and control of the police department; and

**WHEREAS**, the Town's current Town Marshal has requested that the Town Council authorize qualifying members of the police department to participate in the 1977 Police and Firefighters Pension and Disability Fund and that the Town of Pendleton obligate itself to make the required contributions to the Fund; and

WHEREAS, the Town's current Town Marshal believes that the increased benefits available to officers who participate in the Fund will enhance the benefits offered to members of the police department and improve the Town of Pendleton Police Department's ability to recruit and retain qualified law enforcement officers; and

**WHEREAS**, the officers of the Town of Pendleton's Police Department are not eligible to participate in the Fund unless the Town of Pendleton abolishes the current Town Marshal system and establishes a Board of Metropolitan Police Commissioners; and

WHEREAS, the establishment of a Board of Metropolitan Police Commissioners is advantageous because the responsibilities for officer qualifications, officer discipline and selection of the Chief of Police are transferred from elected officials to a police commission; and

WHEREAS, the Town Council of the Town of Pendleton, Indiana, believes that replacing the Town Marshal system with the Board of Metropolitan Police Commissioners

system would be in the best interest of the Town's Police Department and the Town's citizens.

**NOW THEREFORE, BE IT ORDAINED** by the Town Council of the Town of Pendleton, Indiana, as follows:

Title III, Chapter 32, of the Town of Pendleton Code of Ordinances, is hereby amended by adding Chapter 32.03 to read as follows:

# (B) **Board Membership**.

- (l) The Board of Metropolitan Police Commissioners shall consist of three (3) members appointed by the Town Council. The members must be of good moral character, have no felony convictions for criminal acts, and legal residents of the Town of Pendleton. Not more than two (2) members may be of the same political party, if individuals who satisfy this requirement can be found to serve on the Board with reasonable and diligent efforts. Members of the Town's Police Department may not be appointed to serve on the Board. A member of the Town Council may be appointed to serve on the Board as an ex officio member, subject to the provisions set forth herein.
- (2) The Town Council may, by Ordinance, increase the number of Board members to five (5), provided that the amended ordinance and the appointment of Board members satisfy all requirements of Indiana Code 36-8-9-3. I(a) and all other applicable statutes.
- (3) The Town Council may appoint one (1) Town Council member to serve as an ex officio member, who must vacate their membership upon the end of the Council member's term or vacating of office. Said ex officio member may not receive compensation for their service, nor are they required to post a bond.
- (C) **Term**. The Board members' tern-is shall be three (3) years, expiring on January I of the third year after the member's appointment. However, to establish staggered terms, one (1) initial member shall be appointed for a one-year term, one (1) initial member shall be appointed for a two-year term, and one (1) initial member shall be appointed for a

three-year term. Each member serves at the pleasure of the Town Council and may be removed for any cause that the Town Council considers sufficient.

# (D) **Powers and Duties**.

- (l) As provided in Indiana Code 36-8-9-4, the Board shall have the following powers and duties:
- (a) **Appointment of future officers**. The Board shall appoint persons to serve in the Town's Police Department, subject to the qualifications for employment determined by the Board and approved by the Town Council.
- (b) **Appointment of Police Chief**. The Board shall grandfather in and appoint the currently serving Town Marshal to the position of Police Chief.
- (c) Future Appointments of Police Chief. The Board, at such time as necessary, shall appoint one (l) person to serve as Police Chief.
- (d) **Appointment of future civilian employees**. The Board Inay appoint other employees that are necessary to carry on the work of the Police Department.
- (e) **Recommendations for Compensation**. The Board may recommend and the Town Council shall determine the compensation to be paid to members of the Police Department.
- (f) **Safety Board**. The Board constitutes the Town's Safety Board for purposes of suspension, demotion, or dismissal of any member of the Police Department. Proceedings for the suspension, demotion, or dismissal of Police Department members shall be conducted in the manner prescribed by Indiana Code 36-8-3-4. The disciplinary provisions of Indiana Code 36-8-3-4.1 also apply to the Safety Board and the Police Chief.
- (g) **Adoption of General Orders and Policies**. The Board may make general orders and policies for the government and discipline of the Police Department and make special and general orders to the Department through the Police Chief, who is the executive head of the Department.
- (2) The Board shall have all other powers and duties as provided by Indiana statute.
- (3) The Board shall adopt and maintain rules governing the conduct of its business, including, but not limited to, rules concerning its meetings, the selection of appointment of persons to be employed as member of the Police Department, promotions

and demotions of Department members, and the discipline or dismissal of Department members.

- (E) **Oath and Bond**. Before performing any function of a Board Member, each person appointed to serve as member shall:
- (1) Take and subscribe before the Clerk of the Madison County Circuit Court an oath or affirmation of office and an oath or affirmation that in each appointment or removal made by the Board to or from the Town's Police Department, the member will not appoint or remove a member of the Town's Police Department because of the political affiliation of the person or for another cause or reason other than that of the person's fitness to serve as a member of the Town of Pendleton Police Department.
- (2) Give bond in the penal sum of Five Thousand Dollars (\$5,000.00), payable to the State of Indiana and conditioned upon the faithful and honest discharge of the Board member's duties. The bond must be approved by the Town Council.

# **SECTION II**

Title III, Chapter 35, of the Town of Pendleton Code of Ordinances is hereby amended by adding Chapter 35.07 to read as follows:

# 35.07 POLICE CHIEF.

- (A) The Chief of the Town of Pendleton Police Department is the executive head of the Police Department. All members of the Police Department, sworn and civilian, shall serve subject to the orders of the Police Chief.
- (B) The Police Chief shall have the powers and duties prescribed by statute and town ordinance, including statutory disciplinary powers.
- (C) The Police Chief shall be responsible for the keeping of the records and the making of reports concerning the activity of the Police Department as may be required by statute or town ordinance.

# SECTION III

That any other existing Town ordinances, or any parts thereof, inconsistent with or superseded by these revisions to the Town of Pendleton Code of Ordinances are hereby repealed and of no effect.

# AN ORDINANCE ESTABLISHING THE TOWN OF PENDLETON POLICE PENSION BOARD AND ESTABLISHING THE POLICE PENSION FUND

**WHEREAS**, the Town's police department has recently transitioned from a Marshal system under Indiana Code §36-5-7 to a system governed by a board of metropolitan police commissioners under Indiana Code §36-8-9; and

**WHEREAS**, Indiana law requires that if a town establishes a Board of Metropolitan Police Commissioners, the Town shall participate in the 1977 police officers' and firefighters' pension and disability fund ("the 1977 fund"); and

**WHEREAS**, Indiana law requires the Town to establish a Pension Board in connection with its participation in "the 1977 fund"; and

**WHEREAS**, Indiana law also requires the Town to establish a Police Pension Fund in which it will hold all funds to be paid into "the 1977 fund", and this fund should be established; and

**WHEREAS**, the Town Council now finds that a Police Pension Board and a Police Pension Fund should be established, as required by Indiana law.

**NOW, THEREFORE BE IT ORDAINED** by the Town Council of the Town of Pendleton, that:

# **SECTION I**

Title III, Chapter 32 of the Pendleton Town Code, which provides for the Town's Organizations, is amended to adding a new section, Section 32.04, which will read as follows:

# 32.04 POLICE PENSION BOARD

# 32.041 ESTABLISHMENT OF POLICE PENSION BOARD

There is hereby established the Town of Pendleton, Indiana Police Pension Board as provided in Indiana Code §36-8-8 and §36-8-6-2.

WHEREAS, the Town's police department has recently transitioned from a Marshal system under Indiana Code §36-5-7 to a system governed by a board of metropolitan police commissioners under Indiana Code §36-8-9; and

WHEREAS, Indiana law requires that if a town establishes a Board of Metropolitan Police Commissioners, the Town shall participate in the 1977 police officers' and firefighters' pension and disability fund ("the 1977 fund"); and

**WHEREAS**, Indiana law requires the Town to establish a Pension Board in connection with its participation in the 1977 fund; and

**WHEREAS**, Indiana law also requires the Town to establish a Police Pension Fund in which it will hold all funds to be paid into the 1977 fund, and this fund should be established; and

**WHEREAS**, the Town Council now finds that a Police Pension Board and a Police Pension Fund should be established as required by Indiana law.

**NOW THEREFORE, BE IT ORDAINED** by the Town Council of the Town of Pendleton, that:

# **SECTION I**

Title III, Chapter 32 of the Pendleton Town Code, which provides for the Town's Organizations, is amended to adding a new Section 32.05, which will read as follows:

# 32.05 PENSION POLICE BOARD

# 32.051 ESTABLISHMENT OF POLICE PENSION BOARD

There is hereby established the Town of Pendleton, Indiana, Police Pension Board as provided in Indiana Code §36-8-89 and §36-8-6-2.

# 32.052 ORGANIZATION OF BOARD

- A. **Board Members**. The Police Pension Board consists of seven (7) members, as follows:
  - 1.) The President of the Town Council;
  - 2.) The Town Clerk Treasurer:
  - 3.) The Police Chief;
  - 4.) One retired member of the Town's Police Department; and
  - 5.) Three active members of the Town's Police Department.
- B. **Ex Officio Members**. The Town Council President, the Clerk-Treasurer, and the Police Chief are ex officio voting members of the Board.

# C. Election and Terms:

- 1.) Election of Board Members by Police Department Members. The Board members who are the retired police department member and the three active department members shall be elected by the police department members. The initial election will be held at the police station within 30 days of the effective date of this ordinance. Thereafter, the elections shall occur at a meeting of the department members held at the police station on the second Monday in February of each year. The initial members of the Board who are active members of the Police Department will serve staggered terms, with one serving a one-year term, one serving a two-year term, and one serving a three-year term, as determined by the Board. Thereafter, these Board members are elected for terms of three years, succeeding those Board members whose terms of office expire on that date. These members hold their offices until their successors are elected and qualified.
- 2.) **Terms of Other Board Members**. The terms of the President of the Town Council, Clerk-Treasurer and Police Chief will be the same as the term of their respective offices.
- 3.) **Vacancies**. If a vacancy occurs on the Board among the members elected by the departmental members, the police department members shall hold a special meeting upon the call of the Town Council President and elect a successor for the remainder of the vacating member's term.
- 4.) **Notices**. Notice of a meeting at which an election will be held by department members must be given to all active police department members at least five days before a meeting.
- D. **Officers**. The Town Council President serves as the president of the Board, the Clerk-Treasurer serves as its treasurer, and the Board shall elect one member to serve as secretary.
- E. **Quorum**. A majority of the Board's members shall constitute a quorum for transacting business.
- F. **Powers and Duties**. The Board shall have all the powers and duties provided under Indiana Law.
- G. Compensation and Reimbursement. The Board members shall not receive payment for their services and shall be paid only their necessary expenses. However, the Board members, the secretary, and each member of the police department selected by the Board shall be paid their necessary traveling expenses from the 1977 fund when acting upon matters pertaining to the fund as recommended by the Pension Board and approved by the Metropolitan Police Commission.

H. **Bylaws and Rules**. The Board may make all necessary bylaws or rules for it meetings and all matters relating to the conduct of its business, and it shall keep and maintain records of its business.

# **SECTION II**

Title III, Chapter 32 is also amended in order to add the Police Pension Fund, and this new section will read as follows:

# 32.06 POLICE PENSION FUND

- A. **Establishment of Fund**. This is established and created by the Pendleton . Metropolitan Police.
- B. **Source of Funds**. The source of money in this fund will be from payroll deductions for the employer's share and employee's share of pension benefits required by participation in the 1977 Police Pension Fund and any other money appropriated by the Town Council for this fund including but not limited to an initial contribution of \$1000 from the LLE fund.
- C. **Use of Funds**. The money in this fund will be used only for transfer of money to the 1977 Police Officers' and Firefighter Pension and Disability Fund and other lawful purposes.
- D. **Non-Reverting Fund**. This is a non-reverting fund.

# **SECTION III**

Any other existing town ordinances, or any parts thereof, inconsistent with or superseded by these revisions to the Town Code are hereby repealed and of no effect.

# **SECTION IV**

This ordinance will be effective immediately upon its passage.

The Report of Previous Year's Activity will be due on April 15th and submitted to the executive & fiscal body. The Report must also be submitted via the Department of Local Government Finance Gateway System. The report will at least consist of the following:

- Names of the Commissioners (Include when they were appointed or removed)
- Officers of the Commission
- Number of Employees & Salary Information
- Description of Prior Year Expenditures
- TIF Revenue Used for Grants or Loans
- Year Ending Fund Balances
- Allocation Area Detail
  - Revenue Breakdown by Allocation Area
  - Expenditure Breakdown by Allocation Area
  - Fund Balances for All TIF Funds & Bond Funds
  - Outstanding Amounts & Maturity Dates for Obligations
  - Amount Paid on the Obligations
  - Parcel List By Allocation Area (Will Include Gross AV, Base AV, Increment AV, Property Type, Taxpayer Name)

# Annual Update: Presentation to all overlapping taxing units. (IC 36-7-25-8)

The required presentation shall be made at a meeting of the redevelopment commission which invites all overlapping units to attend. Optional: The governing body of a taxing unit that has territory within an allocation area of the redevelopment commission may request that a member of the redevelopment commission appear before the governing body at a public meeting of the governing body. The required presentation must include the following:

- The commission's budget with respect to allocated property tax proceeds
- The long term plans for the allocation area
- The impact on each of the taxing units

#### 2024 Action Items for Fiscal Year 2025

#### Prior to June 15: Determination of Excess Incremental Assessed Value Pass-Through for the Upcoming Pay Year (IC 36-7-14-48)

Prior to June 15, the RDC must make a determination on TIF Pass-Through. If the amount of captured incremental assessed value determined by the RDC is expected to generate more than 200% of the amount needed for debt service payments and the amount necessary for "other purposes" as defined by the Redevelopment Plan, the RDC must submit its determination to the unit's legislative body. The legislative body may elect to approve or modify the RDC's determination on pass-through incremental assessed value. The written determination must be mailed to each of the overlapping taxing districts and be provided to the DLGF via the Gateway system prior to June 15. The written determination will provide the amount of incremental assessed value that will be passed through to the overlapping units. This is still required even if there will be no pass-through incremental assessed value.

# Prior to August 1: Neutralization of Base Assessed Value for the Upcoming Year

Each year, the County Auditor is responsible for certifying assessed values. Part of this process includes preparing a TIF Neutralization calculation that will neutralize the base AV for parcels within each Allocation Area, by taxing district. The neutralization incorporates prior year bases and incremental assessed values and accounts for the changes in assessed value due to items such as a change in tax status, demolition, new construction, abatement roll-off and appeals.

After a lengthy discussion, President Skaggs called for a motion to approve the ordinance. SMFPT Chief Chris Nodine thanked Steve Denny for his time on the SFMPT board. He stated that the territory has added 3 new firefighters at the beginning of 2024 and will add 9 more in July.

The new SMFPT ambulance is slated to be completed on March 26<sup>th</sup>. The chief requested a lease agreement from Republic First National Bank be approved by the council for the financing of the new Medic 82 Ambulance, one new stryker cot & power load system and one remounted Medic 81 ambulance.

Motion to approve the lease agreement was made by Steve Denny and 2<sup>nd</sup> by Jerry Burmeister. Motion approved 5-0.

Assistance chief Jacob Gardner discussed the used ladder truck the SMFPT would like to purchase. Fall Creek Township and the Town of Ingalls have agreed to each donate \$40,000 to help in the purchase price. The Town of Pendleton would then provide \$28,000 for the purchase along with \$28,000 for upfitting expenses and \$43,145 for SCBA equipment. The total from the town would be \$91,273. The Town will need to have a public hearing at the April 11<sup>th</sup> meeting for an additional appropriation.

Motion to approve the amount of \$91,273 and have it on the agenda for the April 11<sup>th</sup> town council meeting was made by Bryan Williams and 2<sup>nd</sup> by Cory Hall. Motion approved 5-0.
