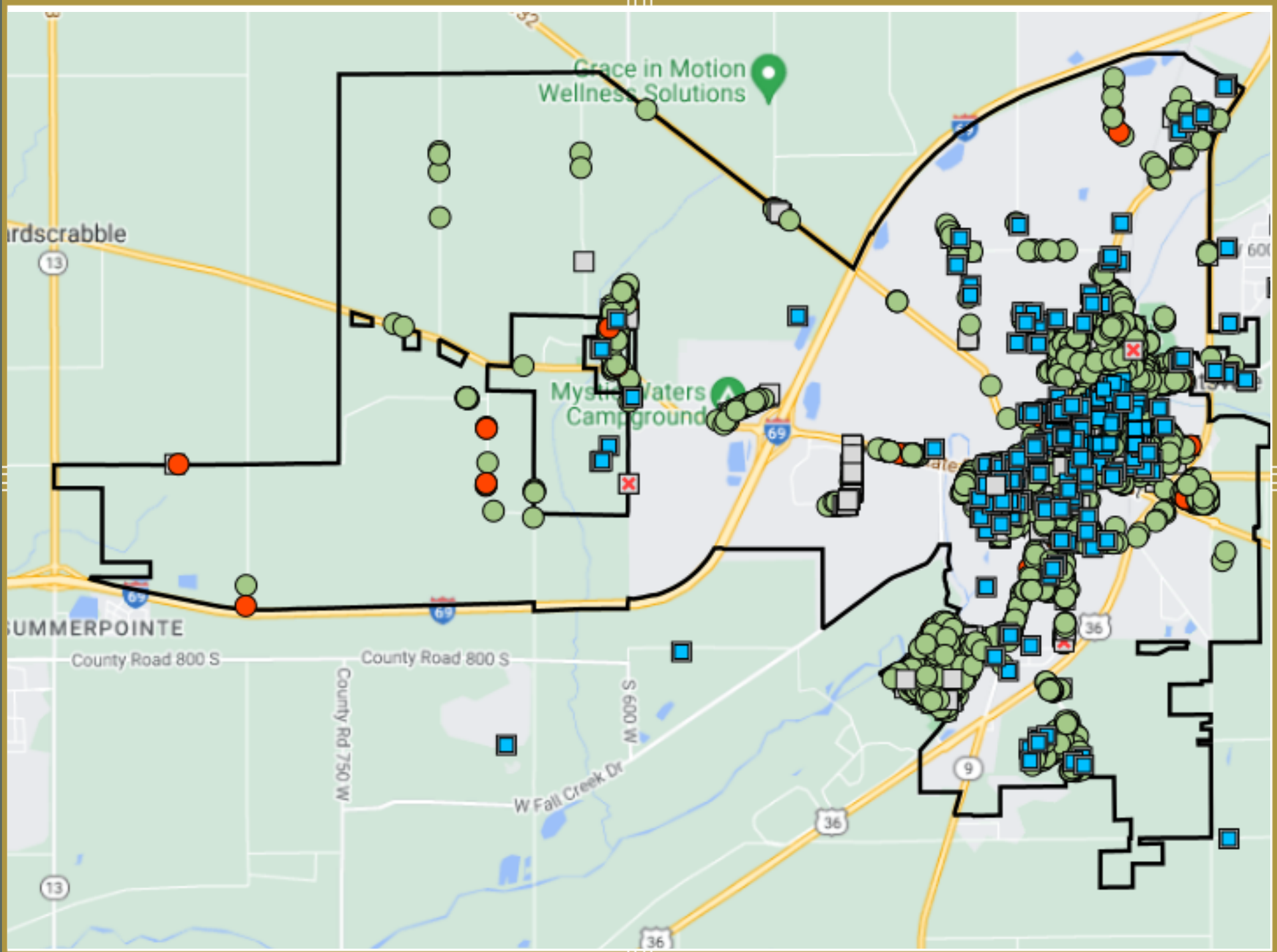

PENDLETON TOWN COURT-2004 to 2024

During 2004 the Pendleton Town Council voted to approve the formation of the Pendleton Town Court.

Excerpt letter from Ty H. Conner (Town of Pendleton counsel-Bose, McKinney & Evans) to Council early in 2002 giving the reasons to have a city or town court would be:

1. having a local convenience to the citizens of the municipality & to the Town's Law enforcement officers.
2. providing a means of avoiding a county court's backlog of cases, this could entail ordinance violations being given very low priority.
3. timely adjudication of moving violations would ensure residents know that violations would be addressed in a serious timely manner.

Our Court was established in 2004 & has provided adjudication over infractions, criminal misdemeanors & ordinance violations over 2004-2023.

Pendleton Court's goals were specifically focused on:

1. efficiency in fair adjudication of violations,
2. minimizing attorney, defendant & law enforcement in-court time, thereby reducing case backlogs & continuances,
3. insuring continuances for defendants/attorneys/law enforcement were closely monitored to prevent delays

PTCt was focused on **user friendly efforts** in setting up case appearances & furnishing explanations of the Court process to the public.

Court administrators were **courteous & effective** in the interface with the public through reviewing specifics as how the court process, the defendants' role & possible outcomes functioned.

Court personnel were sensitive in getting the case adjudicated with the defendants in a **timely basis**. Daily responses to e-mail or telephone messages from defendants or attorneys were priorities.

In 2014 the court's jurisdiction was reduced to only infractions & ordinance violations. The PTCt moved to the Town Hall facilities & continued to provide convenience & service to our community for the majority of our violations. The Court's expenses were reduced through personnel reduction, the Judge's salary reduction along with the benefit of providing for a new area for the Pendleton Police Department in the Court's old location. (Purchase of ground, another facility or major construction would not be required.)

PTCt Court technology efforts

PTCt worked to establish a **common Bond schedule** to all Madison County City & Town Courts beginning in 2004. All area Courts agreed that this would reduce confusion in the bonding process & provide continuity in the bonding procedure for defendants.

PTCt set up **designated Probation facilities** for Madison County working on site with the PTCt Court staff to cover the processes for probation sentences.

A PTCt **Video system** was developed for the improved overall effectiveness in the charging & bonding process linked to the Madison County Jail. This was a forerunner for “zoom” technology. Benefits of the system removed transportation of defendants to/from Jail to the Court by law enforcement, which in turn reduced “in court” time spent by officers on initial charges & bonds.

PTCt involved & supported other area Courts to using **Video hearings**. Jail population was reduced due to this efficient hearing/bonding process.

PTCt was the first in Mad.Co. to implement the State based **Odyssey system** which is a fully integrated case & financial management system designed specifically for Indiana courts’ statewide deployment. Odyssey is a web-based computer system which tied case financial, case histories, defendants’ history, **Odyssey** report-outs in a unified court system.

A **Probable Cause** program was developed for Madison County law enforcement, via the PTwn Ct. to provide uniform charging information.

A PTCt. program was developed for the Madison County Jail to monitor those jailed & prevent MCJ **incarceration** time concerns. The program provided an accurate tool to prevent any additional law suits against MC personnel & its jail for violating the statutes.

PTCt Court Community Outreach efforts

The **Victims’ Impact Program** (VIP) was collaborative effort with the probation system on making sure those adult drivers that had been found guilty of DUI (driving under the influence) to realize the potential consequences of DUI. PTwn Court worked with prior OWL defendants & selected strong speakers to tell their story on the affects & consequences of DUI. The use of “DUI” glasses that duplicated what effect alcohol would have on coordination & perception really.

The “**Choices Program**” visited all levels of the area schools. Stories coming from defendants that had serious consequences due to their life choices had affected were shared with students. The Choices Program focused on drugs & the life casualties they caused. The key focus of this program was to have speakers that “had been there-done that” to share their story. Their emphasis focused in that students had choices that could affect their lives.

The “ **Every 60 minutes**” program was similar to Choices theme. As it used damaged cars, students with mock injuries & deceased members to show that DUI & Choices what an accident scene could be. The scenes were played out in the school parking areas & included police/firemen/medical responders, along with adults that portrayed parents who had children in the accident scenes.

Court Visits involved walk throughs of the Court, provided question & answers of various grade levels as what a court looked like & provided information on the Court’s roles & responsibilities. The “cage”(a single jail cell) & “casket”(standard funeral casket) that was in the court room drew many questions & comments. The props were used to explain possible outcomes for poor choices.

The Court was involved in Southern Madison County **Drug Free Coalition** & supported efforts on drug education via the Intersect group.

Judge G was involved in the Indiana City/Town Courts Association as Vice Pres to help aid City & Town Courts to share their experiences.



To ensure that the Pendleton Waterworks continues to provide you with high quality and safe drinking water, we are asking for your assistance by completing the survey on the back about the type of service line that is inside your home or building.

A water service line is the water pipe that connects your homes/businesses to a water meter.

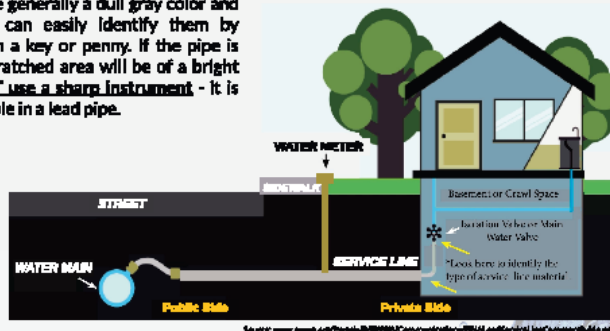
The Environmental Protection Agency (EPA) and the Indiana Department of Environmental Management (IDEM) require that public water utilities identify lead water service lines entering homes and buildings.

Please complete the survey on the back of this document. Even if you do not think that your water service line is made of lead, it is important to complete and return the following survey. If not completed, an alternative means of verification will be necessary; including, door-to-door surveys, verification of the line by excavation, and requesting access for line testing by the Utility.

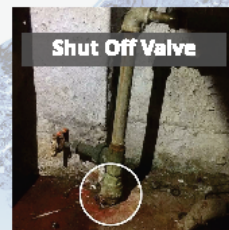
What do lead service lines look like?

Lead service lines are generally a dull gray color and are very soft. You can easily identify them by scratching them with a key or penny. If the pipe is made of lead, the scratched area will be of a bright silver color. **DO NOT use a sharp instrument** - It is easy to puncture a hole in a lead pipe.

A galvanized pipe can also be a dull gray color when scratched. You can verify if the service pipe is made of galvanized steel with a strong magnet - magnets will not stick to a lead pipe.



Lead service lines can be connected to residential and commercial plumbing using solder and have a solder "bulb" at the end, a compression fitting, or another connector made of galvanized iron, brass, or bronze.

Dear Water Utility Customer,

This letter serves to inform you of an important step to protect your drinking water safety. Water pipes made of lead and used for drinking water have been identified as a major health risk.

The Environmental Protection Agency and the Indiana Department of Environmental Management (IDEM) require public water utilities to identify lead water service lines entering your home or building.

Lead water service lines, identified by the property owner or a water utility, entering a structure may be eligible to be replaced at **NO COST** to the property owner.

We are asking home and building owners to assist by inspecting their residence or building for evidence of lead at the shut off valve and completing the enclosed survey. Please see the enclosed form for instructions on how to identify lead water service lines in your home or building.

If you need assistance or are having trouble identifying the type of service line, please call us at 765-778-1301 and a Pendleton Municipal Utility (PMU) team member will schedule an inspection at your convenience.

Even if you do not think your water service line is made of lead, it is important to complete the survey. If not completed, an alternate means of verifying the type of service line will be necessary.

The alternatives include a door-to-door survey, excavation at the meter pit, or requesting access for line testing.

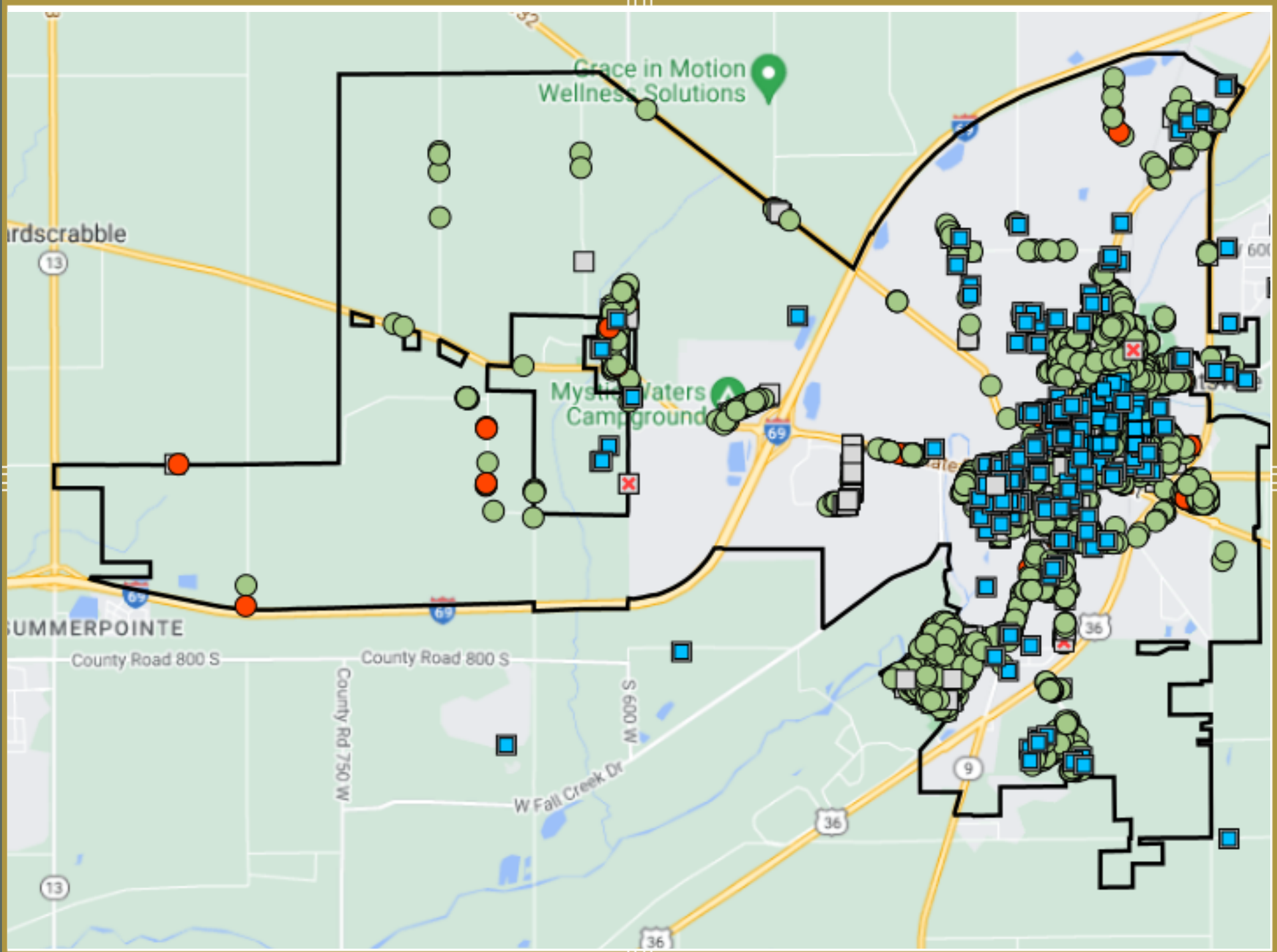
