Funding Requests:

# • FUNDED (\$15,800)

# • Project includes 100 trees to plant in the park; 200 trees for private property owners.

Taylor would like to see if Arborist would come for the tree giveaway, possible identify areas where the trees should be planted.

• SMCF says they will add additional funds if we extend offer of trees to homeowners in Fall Creek Township as part of the Arbor Day Foundation.

• Taylor is project chair with first meeting is March 2<sup>nd</sup> with Carrie from Indiana DNR, Aaron and Denise McKee from the park, Rachel Christenson and Jessica Smith from Town Council. They will discuss plans to link the Bicentennial 200 year celebration with Arbor Day.

• Arbor Day Foundation Event will take place May 9th.

### **B. Memorial Tree Program**

Christi Kelly shared her ideas on how the Memorial Tree Program would be laid out.

Let the donators have some freedom on what they wanted it to say. Persons name or organization in memory of or recognition, a little bio paragraph, any pertinent dates or a simple quote, lyric or scripture and a photo or photos.

Jeanette Isbell shared a copy of Falls Park Memorial Tree Program. They also have a list of trees available for spring planting and fall planting and current cost of the tree. She would like to maybe use some type of software that would allow people to go online and see what memorials we had.

Another idea presented by audience was a brass plaque hammered onto the tree for with a number used as an identifier.

Christi Kelly also hoped we could incorporate special items like the learning tree.

### •Comments from the audience

Sam Hosier Eagle Scout Troop 232

His Eagle Scout troop from 2007 went into the park and mapped every existing tree on GPS and the location and species of each tree and who it was in memory of. The park should have record, if not he does. At that time they also marked historic places in the park. Put new tags on all the trees and that time. Thinks there is a great opportunity to use some of the funds with the new trees to be planted to look at what trees are missing from the 2007 survey and possible replace with the same type tree and same location for the loved ones. One of the problems with the

program he felt was the tags placed on the trees. After time they started to cause damage to the trees. That should be kept in mind when deciding what new signage or tags will be used. Program would allow anyone to come to Park Office and ask for directions to a memorial and the park should be able to direct them to the location. He offered his help in any way, said they scouts are always looking to community service opportunities. Suggested padding the price of trees to build funds for building the program.
