Resolution R22-03 Opposing State Gasoline Taxes

Resolution R22-04 Correct Ordinance Number

Ordinance 22-23 Amending the UDO

Hannah Urbanski stated that the Ordinance strengthens the Solar Energy section of the UDO. Marissa Skaggs stated that Plan Commission gave this a favorable recommendation.

Motion to approve Ordinance 22-23 was made by Marissa Skaggs and 2nd by Steve Denny. Motion approved 4-0.

Ordinance 22-24 Amending Ordinance 21-01 Discharge of Storm Water

Scott Reske presented the information about the Ordinance. It will be prohibited to discharge storm water into the streets and sidewalks if a lateral has been installed.

Motion to approve Ordinance 22-24 was made by Steve Denny and 2nd by Marissa Skaggs. Motion carried 4-0.

Motion to suspend the rules for the second reading was made by Shane Davis and 2nd by Steve Denny. Motion carried 4-0.
