## OLD BUSINESS

# o Community Wellness Center and Heritage Way Extension Update

- o McClintick provided updates on road construction and site construction
  - Presents photos of site work
  - Road should be open ahead of schedule and is coordinated with the Interstate/State St project
  - May be able to avoid using gravel access drive, which will be better for the roads
  - Campbell asked about timing for Wellness Center
    - McClintick reported a request has been made to have electric in July on schedule.

## • Annual Tax Increment Financing Report (TIF)

- Brian Colton from Baker Tilly, formerly known as Umbaugh, presents TIF Report Presentation. Presentation available on RDC Google Drive.
- TIF area "EDA No. 1" (Economic Development Area) has approximately 12 years remaining on life of TIF district
- Anticipate TIF revenues stay approximately the same for 2019
- Explained outstanding obligation for EDA No. 1
  - \$1,765,000 outstanding of \$2MM bond for Lease Rental
  - \$3,835,000 outstanding of \$4,625,000 for water district bonds
- Explained estimated TIF compared to debt payments
  - Ring asks about coverage percentage that would cause concern
    - Colton responded approximately 110% (Coverage is at 121%-122% now)
- o Discussion of Consolidated Redevelopment Area No. 1
  - Bastin asks for explanation of boundaries
  - McClintick explains that area includes rest of Fall Pointe Industrial Park and extends east through town including downtown and area to SR67
  - Colton discusses TIF information for area
- o Discussion regarding 3<sup>rd</sup> TIF area for Wellness Center
  - Ring asks whether TIF includes just the Wellness Center or the entire 25 acres

- Bastin and McClintick explain it covers the entire 25 acres
- Colton explains reason for creating 25-acre area
- Discussion had regarding future projects and potential funding by TIF
  - No commitment on projects, but TIF is available to aid in funding of project and other potential project
- o Colton explains impacts of TIF districts and allocations on overlapping taxing units
  - Colton explains that must pass "But For" test when creating TIF districts
  - Colton discusses potential pass through of TIF revenues if more money is collected than project or future projects
    - Ring and Bastin ask follow up questions regarding which units get funding
      - Colton explained you cannot pick the units and funding passes through to the other taxing units
      - Further explanation that pass through is based on the assessed value and not the actual dollars collected
  - Discussion had regarding impact/effect of referenda or tax rate increases from other units
    - Ring asked about timing for TIF expiration and AV going to general fund

       Colton advised approximately 2031 for first TIF District
    - Denny asks about possible uses of TIF with respect to police or fire
      - Colton explained that the funds must be used for capital costs not salaries – and can be used for public safety [projects but need to be tied to benefit of TIF district
- No further discussion or questions

The next meeting is scheduled for July 25, 2019.
